## Identity and Statement of Educational Purpose

(Signed in the presence of a KCU Financial Aid Administrator)

The student must appear in person at Kentucky Christian University in Grayson, Kentucky, to verify his or her identity by presenting an unexpired valid government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or passport. The institution will maintain a copy of the student's photo ID that is annotated by the institution with the date it was received and reviewed, including the name of the official at the institution authorized to receive and review the student's ID. In addition, the student must sign, in the presence of the institutional official, the Statement of Educational Purpose provided below.

## Alternative Identity and Statement of Educational Purpose

(Signed in the presence of a Notary)

If the student is unable to appear in person at Kentucky Christian University in Grayson, Kentucky, to verify his or her identity, the student must provide to Kentucky Christian University at the address indicated below:

- a) A copy of the student's unexpired valid government-issued photo identification (ID) that is acknowledged in the notary statement below, or that is presented to a notary (such as, but not limited to, a driver's license, a non-driver's identification card, other state-issued identification, or U.S. passport) **AND**
- b) The original signed Statement of Educational Purpose provided herein, which must be notarized.
